Guide for Authors

The Biannul Journal of Sustainable Development of the Geographical Environment publishes scientific findings with the aim of promoting, developing, upgrading and demand-oriented researches in the field of geographic sciences and related knowledges. It is published twice a year in Persian language and abstracts are also published in English. For information on the subject areas of acceptance of articles in these two quarterly journals, refer to its website: https://egsdejournal.sbu.ac.ir.

Also, authors and researchers are requested to pay attention to the following points before submitting the article in order to avoid delays in the refereeing and timely publication of the articles:

• The article must be the result of valid scientific research in one of the subjects of natural, human and environmental geography, with a sustainable development approach.

• The article must not have been sent to another publication or published in another publication at the same time for review and publication.

• Before sending the article, be sure to determine the overlap percentage and attach the matching result file and send it.

• Research innovation is explained and highlighted in the abstract and text of the article.

• Received article will not be returned if accepted or rejected.

• The journal has rights to reject, modify or edit the article.

• The corresponding author is responsible for the correctness of the scientific content of the article, protecting the rights of others and the characteristics of the authors (collaborators).

• All copyrights are reserved for the publication and the authors of the published articles.

The structure of the article should be set and submitted as follows:

The author responsible for the correspondence should send the original file of the article through registration on the journal website. The maximum number of article pages with tables, graphs, photos and maps is 18 pages (6000-7000 words). Before submitting the article, ensure the completion and finalization of the following files according to the format and framework of the journal:

1) Title page (title of the article and full details of authors), 2) Full manuscript, 3) supplementary file (tables, graphs and maps); 4) The result of plagiarism test, and 5) Ethical conflict forms and commitment letter. The details of each file are as follows.

A) File of title page includes:

- Title of the article (Persian and English): The title of the article should cover the entire research; not repetitive; not too long; be without ambiguity and failure.

- name, surname (authors), department, faculty, university, city, country; In both Farsi and English. The author in charge of the correspondence and the author in charge of the article (can be the same or different) should be marked with a number and star.

- The full address of the responsible writer as well as the author in charge of the correspondence should be mentioned including: postal address, mobile and landline phone number, remote number and e-mail address in Farsi and English.

b) Full manuscript (no author(s)'s name) includes:

- In this file, do not mention any information about the author(s) (in the entire and footnotes). Do not use the page break option in the article file.

- A short abstract (Persian and English), a clear summary of the scientific content and should be compiled in a maximum of 250 words in a paragraph. It must include the problem, necessity and purpose, research method, innovation and its results. Refrain mentioning any sources in the abstract.

Keyword: It should indicate important words as single word for searching (maximum 5 words).

Extended abstract: After the judging process, if the article is accepted, it is mandatory to prepare an extended abstract in Farsi and English in the following format:

Each extended abstract should be between 500 and 600 words, arranged in 4 paragraphs including:

background and purpose (20%); materials and methods (50%); findings and discussion (20%) and conclusion (10%).

In addition, the full manuscript should include the following structural components:

- Introduction

It is devoted to explanation of the problem, the importance and necessity of the subject (with reference to new sources), the goals and questions of the research.

- Theoretical foundations and Background

This section is comprehensive and includes the existing world literature on the subject of research and a brief statement of them. In addition, the existing scientific boundaries should be included and at the end, the specific innovation of the current research should be presented compared to previous researches.

- Methodology

This part of the article includes the scope and territory of the research; research method and its steps (research method, statistical population, sampling method, sample size and its determination method, data collection tools and their validation); Introduction of variables and indicators; The application of methods and techniques is assigned.

- Findings and discussion

Detailed and detailed presentation of important findings should be done in accordance with scientific principles and by using the necessary tables and diagrams.

- Conclusion

It includes the presentation and analysis of the results and the significance of the research findings in comparison with other similar research findings, emphasizing the discrepancies and their causes, explaining the generalizability and scientific application of the findings, and providing the necessary guidelines for continuing the research related to the topic, conclusions, and possible recommendations and suggestions.

- Acknowledgement

Thanks and appreciation to the organization providing the data or any kind of facility in the progress of the present study is done in this section. If the financial expenses of the research or the preparation of the article were provided by an institution, the name of the institution should be included at the end of the article in the acknowledgment section. It is not customary for the authors of an article to thank each other.

-Notes

The English equivalent of the methods, terms, names and models mentioned in the text of the article, with numbering in the text, should be written in this section.

-References

How to write references inside the text and at the end of the article:

The sources cited in the text should be written at the end of the article; But in two different ways:

a) **Inside the text:** the method of reference should be by mentioning the family name and the year of publication; Such as: (Sarafi, 2016).

For a source with two authors: (Saeidi and Azizpour, 1388), (Appleyard and Lintell, 1972). If there were more than two authors: (Sarafi et al., 2013) or (Timperio et al., 2004).

b) At the end of the article: presenting sources and sources at the end of the article according to the alphabet should be presented in the following examples:

For the book: surname, first letter of the name of the author or authors. Pub. year (without parentheses). Book title, vol. number., publisher's name, pub. number, place of publication, number of

pages and if the source is E-book, its online access link.

English example of the book:

- Gakenheimer, R., 1978. The Automobile and the Environment: An International Perspective, MIT Press, Cambridge, MA, 120 p.

For the publication: last name, first letter of the name of the author or authors, year of publication. The

title of the article, the name of the publication, the period, and the number of the publication as a number (like the example below), the pages of the article in the publication, the Doi code or the online access link of the article.

English sample of the publication:

- Busche, D. and Sponholz, B., 1992. Morphological and micro morphological aspects of the sandstone karst of eastern Niger. Journal of. Geomorphology: 8 (85), 1-18, Doi: ...

- In case of using internet resources, in addition to following the method of quoting the source that was explained, the internet address of the source should also be given in the following and then the date of internet reference should be mentioned in parentheses. Take as an example:

https://www.amar.org.ir/ (Available at: 1392/3/1)

- **Supplementary file** (tables, graphs and maps): tables, figures and graphs, in addition to being presented in the text, it is necessary to upload them in a separate file in the original Word format (and not photos), with high quality, on the publication's website. and be sent The figures and diagrams of the article must be original and of good quality. The main file of the figures (under Excel, Word and with 600 dpi accuracy) should be provided.

The photos must be clear, legible, scaled and of suitable and desirable quality (300 to 500 dpi) in one of the formats gif, jpg, tif. The size of fonts, especially in the case of curves (Legend) should be chosen in such a way that it is readable after reducing the scale of the figure for printing.

The information in the tables should not be given in the form of figures or diagrams in the article. The number and title should be mentioned above the table. In case of obtaining tables and figures from other sources, mentioning the source under the tables and figures is mandatory.

Tables must be drawn and adjusted in an open manner without surrounding lines (refer to the sample on the publication's website).

Each column of the table must have its own title and unit, if all the figures in the table have the same unit, the unit can be mentioned in the title of the table.

In decimal tables, Persian numbers should be written with / and English numbers should be written with dots. For example, 6/13 or 6.13

Additional explanations of the title and text of the table should be presented as subtitles.

- Writing fomula

Formulas should be written mathematically and with abbreviations and under each formula all abbreviations or variables should be introduced. The word relation is used to name the formulas and they are numbered in order of appearance in the text of the article. It is necessary to have all the relationship numbers

Figures

All Figures (charts, diagrams, line drawings, web pages/screenshots, and photographic images) should be submitted in electronic form. All Figures should be of high quality, legible and numbered consecutively with arabic numerals. Graphics may be supplied in colour to facilitate their appearance on the online database.

Tables

Do not submit tables and graphs as photograph. Place explanatory matters in footnotes, not in the heading. Do not use internal horizontal and vertical rules. Tables should be called out in the text and should have a clear and rational structure and consecutive numerical order. All tables should be numbered (1, 2, 3, etc.). Give enough information in subtitles so that each table is understandable without reference to the text. For each table, please supply a table caption (title) explaining the components of the table. Identify any previously published material by giving the original source in the form of a reference at the end of the table caption. Tables should be with the captions placed above in limited numbers.

Formatting requirements:

• 8.5-by-11-inch paper size.

• Single-spaced text throughout.

Review Process

Submitted manuscripts are reviewed by two or more experts. Reviewers are required to treat manuscripts as confidential. Peer reviewers will be asked to recommend whether a manuscript should be accepted, revised or rejected. They should also alert the editors of any issues relating to author misconduct such as plagiarism and unethical behavior. If a consensus is not reached, a third opinion may be sought. Authors are requested to identify five reviewers who are well qualified to referee the work and would not have a conflict of interest. Authors may also exclude specific individuals from reviewing their manuscript. Manuscripts will be returned without outside review if the Reviewing Editor and the Senior Editor deem that the paper is of insufficient general interest for the broad readership of The Journal of Sustainable Development & Geographic Environment, or that the scientific quality is such that it is unlikely to receive favorable reviews. Editorial rejection allows authors to submit their papers elsewhere without further delay.
